Special Conditions:

- (4) The designated point-of-contact to terminate transmissions if interference occurs is: Mr. Roger Vance (865-599-9636), Ms. Natalie Pike (865-566-8199) or Mr. Brien Evans (865-310-3470).
- (5) Operation is limited to activity for the purpose of testing radionavigation satellite service (RNSS) equipment and systems.
- (6) The test equipment shall only be used indoors only and shall be under the control of the Robertshaw IPD.
- (7) The Robertshaw IPD shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (8) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (9) EIRP is no greater than -140 dbm/24 MHz at 100 feet.
