Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) License must comply with 47 C.F.R. 25.204, e(2), transmission to a geostationary space station in the 13.77-13.78 GHz band must not generate more than 71 dBW EIRP in any 6 MHz band. Automatic power control may be used to increase the EIRP density in a 6 MHz uplink band in this frequency range to compensate for rain fade, provided that the power flux-density at the space station does not exceed the value that would result when transmitting with an EIRP of 71 dBW [for GSO communications] or 51 dBW [for NGSO communication], as appropriate, in that 6 MHz band in clear-sky conditions.
- (5) License must comply with 47 C.F.R. 25.204(i), Within 125 km of the TDRSS sites identified in §25.222(d), transmissions in the 14.0-14.2 GHz (Earth-to-space) band shall not exceed an e.i.r.p. spectral density towards the horizon of 12.5 dBW/MHz, and shall not exceed an e.i.r.p. towards the horizon of 16.3 dBW.
- (6) No automatic renewal for operations in the 13750-14500 MHz band.
- (7) POINT-OF-COMMUNICATION: SES-2 @ 87° W.L. (S2826) and SES-10 @ 66.9° W.L. (S2950)
