- (1) POINT OF COMMUNICATION: INMARSAT Satellite
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) POINT OF COMMUNICATION: INMARSAT Satellite I-3 (AOR-W, longitude=54W); INMARSAT Satellite I-3 (AOR-E, longitude=15.5W); INMARSAT Satellite I-3 (POR, longitude=178E); and INMARSAT Satellite I-4 (Americas, longitude=98W).
- (6) Protection of Space and Earth station authorizations granted by the FCC are required. Applicant must operate on a non interference basis and can not claim protection from interference. Use of satellites must be agreed upon with each satellite operator.
- (7) Operation the frequency band 1626-1660 MHz must not interfere with commercial L band MSS earth station or space station transmitters and receivers.
- (8) Operation is subject to prior coordination the frequency band 1626.5-1660 MHz with LightSquared.
