Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Maintain operation separation from the grandfathered earth stations as defined in Part 90, Sub-part Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz band.
- (4) Consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed geographic areas prior to operation in this band.
- (5) Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications.
- (6) Due to possible interference and operational use within the designated exclusion zone with no Environmental Sensing Capability equipment employed, operation is not permitted in 3550-3650 MHz band.
- (7) All of the experimental devices will be retrieved by Ruckus Wireless Inc. from the participants upon completion of the operation.
