Special Conditions:

- (1) All transmitting and/or receiving equipment used in the study shall be owned by the licensee.
- (2) Licensee is required to ensure that trial devices are either rendered inoperable or retrieved by them from trial participants at the conclusion of the trial. Licensee is required to notify trial participants in advance that operation of the trial device is subject to this condition.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Licensee is required to coordinate operations with existing microwave users in the area to avoid interference.
- (5) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (6) Prior to the start of any operations in the 27.535 - 28.325 GHz band, experimental licensee must notify the National Spectrum Managers Association (NSMA) frequency coordinator by e-mail. This notice must include the name and contact information of the stop buzzer personnel. It must also include the testing parameters, day and times of each testing.

- (7) Experimental fixed stations pointing in the South-West, South or South-East direction are authorized with a maximum antenna elevation of 0 degrees or below from the horizon.
- (8) Experimental station shall use the minimum power level necessary to close the communications link to minimize potential interference to geostationary satellite networks.
