- (1) Operation is subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. Consult the list at http://freq.sbe.org/pdf_files/coordinators.pdf to find the appropriate coordinator.
- (2) Licensee is required to coordinate operations with existing microwave users in the area to avoid interference.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Scientific Applications and Research Associates, Inc. must notch out and not interfere with 2.495 - 2.505 MHz and 4.995 - 5.0 MHz in order not to interfere with the Standard Frequency and Time Signal bands.
- (5) Scientific Applications and Research Associates, Inc. must notch out the frequencies listed in the attachment to the STA application entitled "STA1493 CG Notch list."
- (6) Scientific Applications and Research Associates, Inc. must notch out the following (+/- 2 kHz): 226 kHz, 237 kHz, 261 kHz, 274 kHz, 280 kHz, 284 kHz, 326 kHz, 367 kHz, 382 kHz, 392 kHz, in order not to interfere with air traffic operations.
