This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

The purpose of the operation is to prevent contraband phones at Mississippi State Penitentiary from accessing the Band 14 FirstNet signal.

Special Conditions:

- (1) Licensee POC shall submit a "Stop Buzzer" contact to FirstNet at peter.tomczak@firstnet.gov upon authorization issuance with "kill switch" authority; license POC agrees to immediately cease operations on Band 14 if notified of any interference concerns until any issues are resolved.
- (2) Licensee agrees that this license may be subject to further review by the FCC and possible re-coordination with FirstNet.

Special Conditions:

- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Licensee shall prior coordinate Band 14 use with FirstNet and AT&T. Failure to properly coordinate shall result in FirstNet seeking immediate suspension of the experimental license by the FCC.
- (5) Licensee shall not cause interference to FirstNet NPSBN operations or those approved to operate in Band 14 per license.
