Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Conditions:

- (1) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (2) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (3) Operation in the 1710-1755 or 2110-2155 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (4) Operation on Commercial Mobile Radio Services (CMRS) frequencies requires consent of CMRS licensees to avoid interference.
- (5) Licensee must be made aware that the bands, 1695-1710 MHz, 1755 MHz-1780 MHz and 2155-2180 MHz, are in the AWS 3 band to be licensed in the Commission's current auction proceedings. This license authorization can potentially be impacted as a result of the proceedings and licensee is advised to use another band for long term operation.
- (6) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (7) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
