Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (6) Use of this frequency band is subject to further coordination with the FAA Western coordinator, Los Angeles, California, as necessary to ensure compatibility with existing uses.
