This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) The designated point-of-contact to terminate transmissions if interference occurs is Mr. Dan DeCerbo Jr. at (937) 361-7461.
- (5) Operation is limited to only those frequencies for which Shawntech has obtained written consent from Sprint, T-Mobile, AT&T, Verizon and Cricket. The frequencies of additional licensees may be added to this authorization upon submittal to and approval by the Commission of written consent from those affected licensees.
- (6) A requirement to submit a report detailing the test and results at the end of the experimental period.
- (7) Licensee is required to submit an Interim Report detailing the results of passive testing and testing with controlled phones to ensure proper system calibration for each commercial licensee prior to beginning any uncontrolled testing. This INTERIM REPORT shall be attached as an exhibit to the electronic file.
- (8) AT&T agrees to permit ShawnTech to use the PCS B Block channel 622 (1872.2/1952.2 MHz) within 0.8 km of Ridgeville, SC (33-05-06N/080-17-32W) for a period of September 17, 2010 to December 31, 2010. In authorizing ShawnTech to use AT&T's licensed spectrum in this manner, AT&T accepts responsibility for any failure of an actual subscriber communication which may occur in the area in which ShawnTech is authorized to operate during the course of its operations under the requested experimental STA.
