- (3) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (4) Prior to equipment authorization or a determination of compliance, the device must be accompanied by a conspicuous notice worded as follows: "This device has not been authorized as required by the rules of the Federal Communications Commission. This device is not, and may not be, offered for sale or lease, or sold or leased, until authorization is obtained."
- (5) All shipboard transmissions shall be performed ONLY on U.S.-registered vessels.
- (6) Operation is subject to prior coordination with the Society of Broadcast Engineers, Inc. (SBE), ATTN: Executive Director; 9247 North Meridian Street, Suite 305; Indianapolis, IN 46260; telephone, (866) 632-4222; FAX, (317) 846-9120; e-mail, executivedir@sbe.org; information, www.sbe.org, along a 50 km line inside the coast line to protect Broadcast Auxiliary Low Power and Broadcast Auxiliary Remote Pick-up operations.

Special Conditions:

- (7) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by HSARPA SBIR contract number NBCHC050038. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (8) This license authorizes the use of no more than 25 units.
