This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.
