- (4) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) The occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (6) Point of Communication: Inmarsat I-4F3 satellite (Call Sign S2932).
- (7) Operations of the authorized stations must be in compliance with the terms and conditions specified in the Inmarsat 4F3 geosynchronous L-band satellite grant of US market access, including any coordination agreements.
- (8) Point of Communication: Inmarsat I-4F3 satellite at 98 degrees west longitude and SkyTerra-1 satellite at 101.3 degrees west longitude..
- (9) Operations of the authorized stations must be in compliance with the terms and conditions specified in the Inmarsat I-4F3 geosynchronous L-band satellite (Call Sign S2932) license and the Ligado's SkyTerra-1 geosynchronous L-band satellite (Call Sign S2358) license, including any coordination agreements.
