Special Conditions:

- (1) Licensee is required to ensure that trial devices are either rendered inoperable or retrieved by them from trial participants at the conclusion of the trial. Licensee is required to notify trial participants in advance that operation of the trial device is subject to this condition.
- (2) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.

Special Conditions:

- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (5) Prior to equipment authorization or a determination of compliance, the device must be accompanied by a conspicuous notice worded as follows: "This device has not been authorized as required by the rules of the Federal Communications Commission. This device is not, and may not be, offered for sale or lease, or sold or leased, until authorization is obtained."
- (6) All transmitting and/or receiving equipment used in the study shall be owned by the licensee.
- (7) Locations that appeared in the original application which are not on the license were objected to by NTIA because the proposed testing falls within an exclusion zone designated to protect federal government users of the requested spectrum. - (8) The maximum number of units allowed under this market trial is 450.
- (9) This license will not be renewed.
