- (3) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (4) The PROGRESS REPORT should include, but is not limited to, a description of measurements and results demonstrating compliance with Part 15.109.
- (5) Licensee is required to file a PROGRESS REPORT every 6 months from the date of grant. This progress report shall be filed with Federal Communications Commission; Experimental Licensing Branch, MS 1300E1; 445 12 Street, S.W.; Washington, DC 20554 or uploaded electronically via the OET Experimental Licensing Branch's Electronic Filing Web Site at https://gulfoss2.fcc.gov/prod/oet/index_els.html by using the "Add Attachments" feature.
- (6) CISPR quasi-peak measurements are to be taken in the linear mode only.
- (7) This license authorizes the use of no more than 1000 units at any time.
- (8) Licensee is required to file a LOCATION UPDATE REPORT any time operations are expanded beyond the areas described in the Southern Telecom correspondence to the Commission dated September 28, 2004.
