Special Conditions:

- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) The designated point-of-contact to terminate transmissions if interference occurs is Ms. Lisa Perdue at 585-321-5822.
- (5) Operation is limited to activity for the purpose of testing radionavigation satellite service (RNSS) equipment and systems.
- (6) The test equipment shall only be used indoors and shall be under the control of the Spectracom Corporation.
- (7) The Spectracom Corporation shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (8) EIRP is no greater than -140 dbm/24 MHz at 100 feet.
