- (4) Transmissions on 1280 MHz are required to be between 180 and 250 degrees reference to true north for Syracuse and North Syracuse.
- (5) Transmissions are required to be blanked between 35 to 116 and 190 to 285 degrees reference to true north for Stockbridge.
