Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Applicant project limited to proof of concept demonstrations and testing and will not involve live-duty operations to protect life, property, or safety.
- (3) Applicant must accept interference from any other user of Band 14 and all operations by Applicant will be on a secondary basis.
- (4) Applicant must verify that there is no current potential for interference with FirstNet operations or those approved to operate in Band 14 per license (i.e., any Band 14 incumbents).
- (5) Applicant must verify that there is no current potential for interference with FirstNet operations or those approved to operate in Band 14 per license (i.e., any Band 14 incumbents).
- (6) Applicant agrees that FirstNet has the right to monitor its operations.
- (7) Applicant understands that STAs are for a limited period and that FirstNet must ensure its spectrum is clear as circumstance change and deployment becomes closer. Therefore, Applicant agrees that no further extensions shall be sought for this STA.
