- (3) Prior to operation Sunlight Aerospace Inc. must
 - a. Secure consents from the Advance Wireless Service licensees prior to operation in 1920-2010 MHz, and 2100-2200 MHz bands.
 - b. Obtain consents from the Educational Broadband Service and the Broadband Radio Service licensees prior to operation in 2620-2690 MHz ranges.
- (4) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.

- (6) Prior to commencing any operations in the frequencies below, Sunlight Aerospace Inc. must obtain consent from the following within 58 miles of the contours of the testing area:
 - > 700 MHz Lower Band "D" block licensees (716-722 MHz)
 - > 700 MHz Lower Band "E" block licensees (722-728 MHz)
 - > 700 MHz Upper Band "C" block (746-757 MHz and 776-787 MHz) licensee (Verizon) and/or lessees
 - > Broadband PCS licensees (1850-1910 MHz/1930-1990 MHz)
