Special Conditions:

- (1) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) The applicant must coordinate with the Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d) prior to commencing the test operations.
- (5) Prior to operation, the applicant must coordinate with stations authorized to operate in these frequency bands that are located within a within a 25 mile radius of the transmitter.
- (6) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (7) Licensee must avoid pointing the transmitting antenna main beam gain within 10 degrees of any point on the geostationary orbital arc while transmitting signals in the 27.5-28.35 GHz and 37-40 GHz bands.

Special Conditions:

- (8) Licensee shall ensure that the transmitting fixed station antenna(s) main beam gain tip down when possible and avoid pointing above the horizon to protect satellite stations.
- (9) No automatic renewal for operations in the 27.5-28.35 GHz and 37-40 GHz bands.
- (10) This authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications.
- (11) Operations are on a non-interference basis (NIB) and shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and notify the FCC in writing.
- (12) Application granted pursuant to Memorandum Opinion and Order, Declaratory Ruling, and Order of Proposed Modification in Applications of T-Mobile US, Inc., and Sprint Corporation for Consent To Transfer Control of Licenses and Authorizations, WT Docket No. 18-197, FCC 19-103, adopted Oct. 16, 2019, and released November 5, 2019.
