This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. - (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.

Special Conditions:

- (4) Licensee must maintain separation from the grandfathered earth stations as defined in Part 90 subpart Z, or coordinate an agreement with the grandfathered earth station licensees in the area prior to operation in 3650-3670 MHz.
- (5) Operations will not cause harmful interference to any existing registered stations in 3650-3700 MHz, and notify the registered users in the area prior to accessing to 3650-3670 MHz.
