Special Conditions:

- (1) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (5) Operation in the 1710-1755 or 2110-2155 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (6) Operation is NOT PERMITTED using the frequency bands: 734-746 MHz, 746-756 MHz, 2485-2642 MHz and 2652-2690 MHz.
- (7) Operation in the frequency band 2642-2652 MHz requires consent of affected Educational Broadband Service/ Broadband Radio Service (EBS/BRS) licensees.
