Special Conditions:

- (1) Prior to equipment authorization or a determination of compliance, the device must be accompanied by a conspicuous notice worded as follows: "This device has not been authorized as required by the rules of the Federal Communications Commission. This device is not, and may not be, offered for sale or lease, or sold or leased, until authorization is obtained."
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

Special Conditions:

- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) The applicant must obtain consents from the Advance Wireless Service licensees prior to operation in 1710-1785 MHz, 1749.5-1784.9 MHz, 2110-2170 MHz and 1915-1920 MHz bands.
- (5) The applicant must obtain consents from the Educational Broadband Service and the Broadband Radio Service licensees prior to operation in 2500.001-2690 MHz range.
- (6) The applicant must coordinate with the local Society of Broadcast Engineers frequency coordinator and the affected Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d) prior to operation in 925-960 MHz band.
- (7) Operation is NOT PERMITTED using the frequency band 756-806 MHz, 2300-2500 MHz and 3550-3700 MHz.
- (8) Prior to commencing any operations in the frequencies below, the applicant must obtain consent from the following within 50 miles of the contours of the testing area:
 - 700 MHz Lower Band "A" block licensees (698-704 MHz/728-734 MHz)
 - 700 MHz Lower Band "B" block licensees (704-710 MHz/734-740 MHz)
 - 700 MHz Lower Band "C" block licensees (710-716 MHz/740-746 MHz)
 - 700 MHz Upper Band licensees (746-758 MHz and 775-788 MHz)
 - Cellular licensees (824-849 MHz/869-894 MHz)
 - Commercial Air-Ground licensee (849-851 MHz/894-896 MHz)
 - SMR licensees (896-901 MHz/935-940 MHz)
 - B/ILT licensees (896-901 MHz/935-940 MHz)
 - Narrowband PCS licensees (901-902/930-931/940-941 MHz)
 - Location & Monitoring Service licensees (902-928 MHz)
 - Paging Service licensees in 929 MHz and 931 MHz
 - Broadband PCS licensees (1850-1910 MHz/1930-1990 MHz)
