Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) The designated point-of-contact to terminate transmissions if interference occurs is Dr. Stuart Wagner, Phone Number: 732-699-2160.
- (5) This authorization is for equipment that is intended for export only.
- (6) No equipment shall be developed in this band for use in the US since it is a Federal Government band for radiolocation. Any development for use in the US needs to be done in an approved FCC band. WiMAX should not be developed in the band 3300-3650 MHz for US sales.
- (7) No WiMAX equipment in the band 3300-3650 MHz will be offered for US sales.
- (8) Telcordia Technologies, Inc., needs to be aware of possible interference from high power government radars in the band 3300-3650 MHz.
- (9) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by US Army contract W15P7T-05-C-R402. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (10) The radius of operation will be within 4 km of Middlesex, NJ. (NL 40-32-24; WL 74-28-24)
- (11) Applicant needs to be aware of possible interference from high power government radars in the frequency band 3300-3650 MHz.
