Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.

Special Conditions:

- (3) GPS re-radiators are limited to a maximum EIRP value that will result in power levels not to exceed a power spectral density of -140 dBm/24 MHz measured at a distance of 100 ft from the building where the test is being conducted. Any malfunction, misalignment, or tampering of the equipment or its location which results in an increased power spectral density outside the building could cause harmful radio frequency interference to GPS receivers, including those in aircraft and/or ground based facilities.

- (5) Licensee shall maintain testing according to the NTIA requirements of section 8.3.28 as stated in the application.
- (6) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (7) Textron Aviation shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (8) The test equipment shall only be used indoors and shall be under the control of Textron Aviation Inc.
- (9) Operation is limited to activity for the purpose of testing radio navigation satellite service (RNSS) equipment and systems.
- (10) No EIRP greater than -140 dBm/24 MHz at 100 feet is used.
