Special Conditions:

- (1) Prior to equipment authorization or a determination of compliance, the device must be accompanied by a conspicuous notice worded as follows: "This device has not been authorized as required by the rules of the Federal Communications Commission. This device is not, and may not be, offered for sale or lease, or sold or leased, until authorization is obtained."
- (2) Licensee is required to ensure that trial devices are either rendered inoperable or retrieved by them from trial participants at the conclusion of the trial. Licensee is required to notify trial participants in advance that operation of the trial device is subject to this condition.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Licensee shall ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed areas.

Special Conditions:

- (6) Licensee must maintain operation separation from the grandfathered earth stations as defined in Part 90, Subpart Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz band.
- (7) Licensee be aware that FSS earth stations are licensed above 3700 MHz and if any interference occurs, the experimental licensee of this authorization will be subject to immediate shut down.

- (8) Operations are on a non-interference basis (NIB) and shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and notify the FCC in writing.
