- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (4) Operation requires consent of affected Educational Broadband Service/Broadband Radio Service (EBS/BRS) licensees.
- (5) Operation is subject to prior coordination with affected existing and future Fixed Microwave Service licensees in using the frequency bands: 1850-1990 and 2130-2200 MHz.
- (6) This frequency assignment in one of the bands 1435-1525, 2310-2320 and 2345-2390 MHz was coordinated prior to its authorization with Area Frequency Coordinator (AFC), who also coordinated it, as appropriate, with the Aerospace and Flight Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with AFC, as necessary to ensure compatibility with existing uses.
- (7) Licensee must consent from Advanced Wireless Service licensees before utilizing 1748 MHz.
- (8) The designated point-of-contact to terminate transmissions if interference occurs is Loren Ayotte (425) 647-5011.
- (9) Operation is NOT permitted on the frequency 411 MHz in Klamath Falls, OR and Marana, AZ due to potential interference to Department of Homeland Security.
- (10) Operation is NOT permitted using the frequency 5754 MHz in Glasgow, MT.
