This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. - (4) The licensee shall avoid interference to 802.11b/g equipment due to the power level requested for use in the 2.4 GHz band.
- (5) The 219-220 MHz band is for wildlife telemetry and no aeronautical mobile operations are permitted in this band.
- (6) Operation is subject to prior coordination with affected existing and future Fixed Microwave Service (Part 101) licensees in accordance with 47 CFR, Part 101.103(d) when using the frequencies 2434 MHz and 2473 MHz.
- (7) License extension is granted according to Section 5.61(b) of the FCC rules pending the disposition of application 0010-EX-PL-2008. Operations may continue in accordance with the other terms and conditions of the temporary authority pending disposition of the application, unless the applicant is notified otherwise by the Commission.
