- (1) Assignment in frequency band 960-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Northwest Coordinator, Seattle, WA. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Northwest Coordinator, Seattle, WA, as necessary to ensure compatibility with existing uses.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.

Special Conditions:

- (5) Prior to activation, Boeing must coordinate with Mr. Russ Potter at 360-396-7075.
- (6) Operation in the Everett, WA is only permitted using the frequency band 108-118 MHz in the band 108-137 MHz.
- (7) Operation is subject to prior coordination with AFTRCC and FAA.
