- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Subject to coordination with the Western Area Frequency Coordinator located at the Navy Pacific Missile Test Center, Pt. Mugu, Cal., prior to use within a 322 kilometer radius of Pt. Mugu or in California south of Latitude 37 30' North. Coordinate with WAFC prior to testing 760-939-6948.
- (5) Operations under the authority of this assignment are subject to immediate adjustment, including cessation, if they result in harmful interference to the operations of the FAA assignments.
- (6) Operation is NOT PERMITTED using the frequency bands 1610-1660 MHz and 14200-14400 MHz.
