Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Prior to operating in the 14.47-14.5 GHz frequency band within 160 km of the radio observatories listed in US 203, licensee shall coordinate with the National Science Foundation (NSF) and notify the Commission of the results of that coordination.
- (4) Operation is NOT PERMITTED using the frequency 14518-14548 MHz in Edwards AFB, CA.

- (6) All testing at the Department of Defense facilities will be pre-coordinated with the range frequency manager, and operations will be restricted to specific frequency channels authorized by the facility.
- (7) Boeing will be coordinated with FAA office to complete certificate of authority as required by FAA regulation.
