Special Conditions:

- (1) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (2) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) Licensee must get consent from Education Broadband Service / Broadband Radio Service and Advanced Wireless Service licensees in the immediate area.

- (7) Operation is NOT permitted on 915.4-928 MHz, 932-935 MHz and 941-944 MHz.
