Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) The designated point-of-contact to terminate the systems if interference occurs is Glenn Torgerson at 425-495-2798.
- (4) Boeing operations shall be limited to the frequencies between 1617.775-1626.5 MHz.
- (5) Boeing shall coordinate its use of the frequencies with Iridium prior to any use of the spectrum.
- (6) The ERP for operating the frequency band is 15.85 Watt.
