Special Conditions:

- (1) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (4) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) Assignment in frequency band 960-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Northwest Coordinator, Seattle, WA. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Northwest Coordinator, Seattle, WA, as necessary to ensure compatibility with existing uses.

- (7) The designated point-of-contact to terminate transmissions if interference occurs is Jason Bommer at 206-544-7515.
- (8) Licensee must get consent from Sirius XM Radio, Inc. prior to operate the frequency 2320-2345 MHz.
- (9) Licensee must get consent from Educational Broadband Service / Broadband Radio Service licensees prior conducting the test in 2500-2690 MHz.
- (10) Licensee must obtain consent from Advanced Wireless Service licensees prior to conducting the tests in 1710-1775MHz, 1915-1920 MHz, 1955-2000MHz, 2020-2025MHz, and 2110-2180MHz.
- (11) Operation is subject to coordinate with the local Society Broadcast Engineers, Inc. coordinator prior to performing the tests in the rest of the proposed frequency bands.
- (12) Prior to operation the frequency bands 3701-4990 MHz and 5000-10680 MHz, licensee must coordinate with Navy and Marine Corps Spectrum Office (NMSCO) Northwest at 360-396-7075.
- (13) Prior to operation the frequency band 15400-23600 MHz, licensee must coordinate with Western Area Frequency Coordinator (760) 939-6948.
- (14) Operation is subject to prior coordination with FAA Northwest Regional Office, 1601 Lind Avenue, S.W. Renton, Washington 98055, and PH: 206-227-2464.
