Special Conditions:

- (1) Any operation in the 1850-1990 and 2130-2200 MHz band must be coordinated with the existing and future users to avoid interference. Emission types may vary under the experiment.
- (2) This frequency assignment in one of the bands 1435-1525, 2310-2320 and 2345-2390 MHz was coordinated prior to its authorization with AFMO CONUS, Ft. Sam Houston, TX, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with AFMO CONUS, Ft. Sam Houston, TX, as necessary to ensure compatibility with existing uses.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (6) Licensee must get consent from Advanced Wireless Service licensees prior to operation on 1738 MHz.
- (7) Licensee must get consent from Education Broadband Services /Broadband Radio Services licensees prior to operation on 2512MHz, 2570MHz and 2630MHz.

Special Conditions:

- (8) Operation is subject to coordinate with the local Society of Broadband Engineers coordinator prior to operation.
- (9) Operation on this assignment is subject to immediate cessation if it causes harmful interference to Federal Aviation Administration.
- (10) Operation is subject to prior coordination with FAA Northwest Regional Office, 1601 Lind Avenue, S.W Renton, Washington 98055, and phone: 206-227-2464.
- (11) The designated point of contact if having interference occurs is Daniel K Griffith 425-245-2043.
- (12) Operation is NOT PERMITTED using the frequencies 756-768 MHz and 788-798 MHz.
- (13) Maintain separation from the grandfathered earth stations as defined in Part 90, subpart Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700MHz.
- (14) Ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700MHz, and notify the registered users in the area.
- (15) Operation is NOT Permitted using the frequency band 1479.3-1489.6 MHz except 1480.3 MHz.
