Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

Special Conditions:

- (3) Licensee should be aware that Federal Aviation Administration (FAA) stations may be licensed on frequencies in the bands 399.9-405.5 MHz, 406.5-445 MHz, 13250-14200 MHz, 14400-17700 MHz and 17800-18000 MHz, and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government contract numbers N00019-92-C-0059 and N00019-99-C-1226. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) The frequency assignment in the bands 1050-1080 MHz, 1214-1216 MHz, 5000-5250 MHz and 9000-9200 MHz was coordinated prior to authorization with the FAA Western Coordinator, Los Angeles, California. Use of the frequency or band under the authority of this assignment is subject to such further coordination with the FAA Western Coordinator, Los Angeles, California as necessary to ensure compatibility with existing uses.
- (6) The frequency assignment in the band 2310-2390 MHz was coordinated prior to authorization with the Area Frequency Coordinator, Ft. Huachuca, Arizona, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the AFC, Ft. Huachuca, as necessary to ensure compatibility with existing uses.
- (7) The designated point-of-contact to terminate transmissions if interference occurs is Mr. Don Johnson at (480)-891-2035 or at (480) 891-2035.
- (8) Operation is NOT PERMITTED using the frequency bands: 2690-2900 MHz, 410.2875-410.3125 MHz and 413.1-413.125 MHz.
- (9) The application must re-coordinate with Aerospace and Flight Test Radio Coordinating Council (AFTRCC) prior to submit renewal application.
