Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) The designated point-of-contact to terminate transmissions if the interference occurs is Rob Boynton at 703-872-4666.
- (5) Operation is NOT PERMITTED using bandwidth exceed 18.4 MHz at three locations DE, NJ and KS.
- (6) Operation is NOT PERMITTED using the following frequency bands:
14389.00-14411.00 MHz for AZ.
- (7) Operation is NOT PERMITTED using the following frequency bands:
13750.00-13993.98 MHz for FL.
- (8) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by U.S. Department of Defense. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (9) POINTS OF COMMUNICATION: ALSAT.
- (10) In accordance with Article 4.4 of the ITU Radio Regulations, the operations authorized herein shall not cause harmful interference to, and shall not claim protection from harmful interference caused by, a station operating in accordance with the provisions of the ITU Constitution, the ITU Convention, and the ITU Radio Regulations.
- (11) Operation is subject to coordinate with National Science Foundation (NSF) at esm@nsf.gov prior using the band segment 14.47-14.5 GHz.
- (12) Operation is NOT PERMITTED using the following frequency bands:
13750-13771.77 MHz, 13792.26-13938.94 MHz, 13957.38-14002.46 MHz and 14404.00-14426.00 MHz for NJ, KS, DE due to potential harmful interference US Navy operations.

Special Conditions:

- (13) All operations shall be coordinated with the NASA GSFC Spectrum Office at NASA-DL-GSFC-SPECTRUMMANAGEMENT@MAIL.NASA.GOV, at least 7 days in advance of operations when operations occur within 125km of NASA White Sands Center (WSC), NM.
- (14) All operations shall be coordinated with the NASA GSFC Spectrum Office at NASA-DL-GSFC-SPECTRUMMANAGEMENT@MAIL.NASA.GOV, at least 7 days in advance of operations when operations occur within 125km of NASA Blossom Point Complex, MD.
