- (4) Due to concerns with third harmonic emissions from these airborne stations interfering with extremely sensitive radio astronomy facilities operating nearby in the 1400 - 1427 MHz passive band. - (5) Operation is NOT permitted on the frequency band 462.94-463.19675 MHz and 467.94-468.19675 MHz.
