- (4) Operation is NOT permitted using the frequencies 303.275 MHz, 314.45 MHz, 343.3 MHz and 375.475 MHz, but licensee is authorized using the frequencies 302 MHz, 314.8 MHz, 344.9 MHz and 374.7 MHz for this experiment.
