- (3) The designated point-of-contact to terminate transmissions if interference occurs is Steven Gall (714) 896-5143 or (714) 697-5399.
- (4) Boeing Company can use the frequencies 235.6 MHz, 239.575 MHz, 346.45 MHz and 357.4 MHz with the emission designators 25K0F3E and 25K0W7D for this experiment.
- (5) Operation is NOT PERMITTED using the frequencies 230.475 MHz, 241.525 MHz, 344.8 MHz and 358.2 MHz.
- (6) Operation is subject to prior coordination with AFMO CONUS at 210-221-2050/2820.
