Special Conditions:

- (4) Operation is subject to prior coordination with the with the local Society of Broadband Engineer frequency coordinator and the affected Fixed Microwave Service licensees in each proposed area.
- (5) The designated point-of-contact to terminate transmissions if interference occurs is Patrick McCauley at 610-591-8907.
- (6) Licensee will not use to develop equipment.
- (7) Licensee will not transmit in the direction of 85 degrees plus or minus 5 degrees per FAA requests.
