- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Stop Buzzer, Jacob Kuo cell (310) 227-6371 or Boeing 24 hour NOC hotline: (855) 556-1001.
- (4) All Boeing operations granted on an experimental basis (STA) shall be conducted on an unprotected, non-interference basis to authorized DoD stations.
- (5) This STA is limited to 6 months and is subject to re-coordination with AFSMO upon renewal.
- (6) The GetSat Micro Terminal (IRAD Terminal) in El Segundo, CA, must be operated in the fixed configuration (e.g. not authorized to be used/transmitted while in motion).
- (7) As soon as possible, but no later than 3 business days prior to any planned testing, Boeing is required to provide Jimmy Nguyen (Email: jimmy.nguyen@us.af.mil , AFSMO) and Travis J. Inghram (Email: travis.j.ingram.civ@mail.mil , ARSTRAT) with the planned testing dates/duration and the stop buzzer POC for the testing. If planned testing is in conflict with DoD operations, additional evaluations and/or restrictions will be required.
