Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Prior to commencing any operations in the frequencies below, the applicant must obtain consent from the following within 50 miles of the contours of the testing area:
 - 700 MHz Lower Band "A" block licensees (698-704 MHz/728-734 MHz)
 - 700 MHz Lower Band "B" block licensees (704-710 MHz/734-740 MHz)
 - 700 MHz Lower Band "C" block licensees (710-716 MHz/740-746 MHz)
 - 700 MHz Upper Band "C" block (746-757 MHz and 776-787 MHz) licensee (Verizon) and/or lessees
 - SMR licensees (809-824 MHz/854-869 MHz)
 - B/ILT licensees (809-824 MHz/854-869 MHz)
 - Cellular licensees (824-849 MHz/869-894 MHz)
 - Broadband PCS licensees (1850-1910 MHz/1930-1990 MHz)
 - WCS (2305-2320 MHz/2345-2360 MHz) licensee (AT&T)
- (4) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (5) Licensee shall ensure that the transmitting station antenna(s) main beam gain tip down when possible and avoid pointing above the horizon to protect satellite stations.
- (6) The authorized station must be in compliance with the Federal Aviation Administration (FAA) requirements as set forth in Section 17.4 of the Commission's Rules.
- (7) The authorized station must be in compliance with environmental requirement set forth in Section 1.1307 of the Commission's Rules.
- (8) This authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications.
- (9) Operations are on a non-interference basis (NIB) and shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and notify the FCC in writing.

Special Conditions:

- (10) Licensee must obtain consents from the Advance Wireless Service licensees prior to accessing to 1710-1780 MHz band.
- (11) Licensee must obtain consents from the Educational Broadband Service and the Broadband Radio Service licensees prior to operation on the frequencies in 2495-2690 MHz range.
- (12) Licensee must coordinate with the Fixed Microwave Service licensees prior to operation in 2496-2500 MHz band.
