Renewal of this License is subject to prior coordination with AFTRCC Frequency Advisory Committee, www.aftrcc.org”

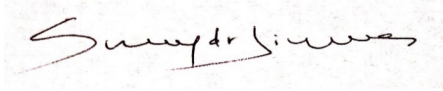
