Special Conditions:

- (3) GPS re-radiators are limited to a maximum ERP value that will result in power levels not to exceed a power spectral density of -140 dBm/24 MHz measured at a distance of 100 ft outside the building of operation. Any malfunction, misalignment, or tampering of the equipment or its location which results in an increased power spectral density outside the building could cause harmful radio frequency interference to GPS receivers, including those in aircraft and/or ground based facilities.
- (4) The designated point of contact to terminate the systems if interference occurs is Mike Wuebbeling 219-308-3971 and Ben Wetton 219-916-6166.
- (5) Licensee shall maintain testing according to the NTIA requirements of section 8.3.28 as stated in the filed application.
- (6) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (7) The test equipment shall only be used indoors and shall be under the control of the applicant.
