- (4) Testing is authorized as a temporary pico cell experiment under the authority of Part 5 of the Commission rules and does not constitute a waiver of Section 22.925 of the Commission rules.
- (5) Pico cell operations shall not cause interference to licensed services and are subject to immediate shut down until any interference issues are resolved.
