Special Conditions:

- (1) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Licensee must get consent of ALL Lower Band 700 MHz C Block (710-716 MHz/740-746 MHz) licensees within 25 miles of the locations of the test.
- (5) License must get consent of Upper Band 700 MHz C Block (746-757 MHz/776-787 MHz) licensee (Verizon) within 25 miles of the locations of the test.
- (6) Licensee must provide notification of Lower Band 700 MHz E Block (722-728 MHz) licensee within 25 miles of the locations of the test.
- (7) Operation is subject to prior coordination with the local Society of Broadcast Engineers coordinator prior to operation to protect the Low Power Broadcast Auxiliary operations on 602-608 MHz and 614-698 MHz.
- (8) Operation is NOT PERMITTED using the frequency band 756-768 MHz and 788-798 MHz.
