- (4) The GetSat Micro Terminal in Herndon, VA, must be operated in the fixed configuration (e.g. not authorized to be used/transmitted while in motion).
- (5) As soon as possible, but no later than 3 business days prior to any planned testing, Boeing is required to provide Jimmy Nguyen (Email: jimmy.nguyen@us.af.mil, AFSMO) and Travis J. Inghram (Email: travis.j.ingham.civ@mail.mil, ARSTRAT) with the planned testing date/duration and the stop buzzer POC for the testing. If planned testing is in conflict with DoD operations, additional evaluations and/or restrictions will be required.
