Special Conditions:

- (1) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (2) GPS re-radiators are limited to a maximum ERP value that will result in power levels not to exceed a power spectral density of -140 dBm/24 MHz measured at a distance of 100 ft outside the building of operation. Any malfunction, misalignment, or tampering of the equipment or its location which results in an increased power spectral density outside the building could cause harmful radio frequency interference to GPS receivers, including those in aircraft and/or ground based facilities.

Special Conditions:

- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) The designated point-of-contacts to terminate transmissions if interference occurs are Kevin Callahan 206-427-6478 and Christina M Westover 425-342-7015.
- (6) Operation is limited to activity for the purpose of testing radio-navigation satellite service (RNSS) equipment and systems.
- (7) The test equipment shall only be used indoors and shall be under the control of the Boeing Company.
- (8) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (9) Licensee shall maintain testing according to the NTIA requirements of section 8.3.28 as stated in the filed application.
