Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) The potential for severe harmful interference to the Fixed Microwave Service operations in the adjacent bands is very high. The Boeing Company must successfully coordinate with the Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d) prior to operation in 20.2-21.2 GHz and 30-31 GHz bands.
- (4) As soon as possible, but no later than 2 business days prior to any planned testing, The Boeing Company is required to provide the planned testing dates/duration and the stop buzzer POC to the following personnel: Jimmy Nguyen (Email: jimmy.nguyen@us.af.mil, AFSMO) and Travis J. - (5) This STA is valid only for the time frame during the period 9/11/2017 thru 3/11/2018. Any additional testing must be re-coordinated with the Air Force Spectrum Management Office (AFSMO).
